

FBEC 2025 Registration Tutorial

If you have not set up a login with AFFI (after August 1, 2024), please follow the steps below to create an account. The system will send you a verification email that you will need to reference.

ALL ATTENDEES MUST COMPLETE THIS STEP TO REGISTER FOR THE EVENT.

Step 1—Visit <https://2025-food-and-beverage-environmental-conference.events.affi.org/> and click on **Registration—Register Now** at the top left of your screen.

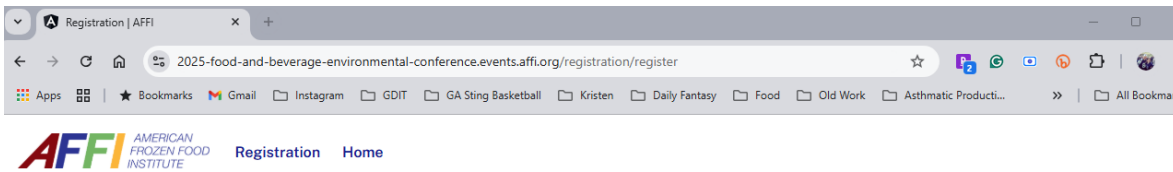
